WESTERN UNION VISA OLYMPICS PACKAGES OFFICIAL TERMS AND CONDITIONS

- 1. ELIGIBILITY: The Visa Olympics Packages Promotion (the "Promotion") conducted by The Western Union International Bank GmbH (the "Promoter"), sponsored by Visa Europe Limited (the "Sponsor"), and administered by 160over90 (the "Agency"), herein after referred to as "the Released Parties," and is open only to legal residents of the Federal Republic of Germany, and who are 18 years of age or older at time of entry. medicine, security; Airport transfers for 2 people in Paris and a Paris Metro Card; Return flights for 2 people from Germany to Paris (incl. CO2 compensation); **(b) Non-Ceremony Package:** 2 nights, in a double accommodation room, in Paris in a hotel in the heart of the city from 4 - 6 August with breakfast included; 2 tickets for two Olympic sporting events; Visa prepaid card with a value of € 200 for meals; Visa welcome package worth € 400; Visa Concierge in the hotel as well as support in the areas of events, medicine, security; Airport transfers for 2 people in Paris and Paris Metro Card; Return flights from Germany to Paris for 2 individuals (incl. CO2 compensation). Airline tickets are redeemable for flights originating from Germany to Paris, France and must be booked by the Agency.
